Checklist & Fees

1. Complete the attached application including all required signatures.
2. Submit two (2) copies of a sketch or map identifying the location of the property with a North arrow.
3. Submit two (2) copies of the utility plan identifying all utilities on and adjacent to the property. If this is new construction, plans should be stamped by a Professional Engineer.
4. For new construction, submit two (2) copies of the building plans and plumbing/sewer plans. These plans should show the street location with the public water lines and the proposed water connection to either an existing water stub or a lateral. One (1) digital copy (CAD and pdf) should be provided as well. These plans should be stamped by a Professional Engineer.
5. Submit two (2) copies of plans for special equipment, like grease traps, which will be used in the building. Indicate size and capacity of equipment and plumbing arrangements.
6. **Once submitted to the Town of Cumberland, the permit application will be reviewed by the Director of Utilities who will determine if the application is approved, declined or needs further information. You will receive a phone call determination. When the application is approved you will come back to pick up and pay the fees for your permit.**
7. Submit application fees made payable to the appropriate party as detailed here:

a. Gem Water Connection – Payable to “Town of Cumberland”.

- i. Application & Plan Review Fee.....\$ 50.00
- ii. Plant Contribution Fee.....\$1,200.00 per Equivalent Dwelling Unit (EDU).
- iii. System Contribution Fee.....\$ 850.00 per platted acre.
- iv. Construction Inspection Fee.....\$ 50.00.
- v. Connection Fee -- according to the following table:

1"	\$ 1,100.00
1-1/2"	\$ 1,500.00
2"	\$ 3,500.00
3"	\$ 4,000.00

b. Gem Water Repair – Payable to “Town of Cumberland”.

- i. Construction Inspection Fee.....\$ 50.00.
8. A fully completed Water Service Agreement and supporting documents are required for all new construction permits and as required by the administrator(s) of this permit.
 9. Easements shall be provided if needed to gain access to water infrastructure and proof these have been provided shall be provided at time of application.
